### Secretaries Report- Andy Meyer

### Alliance Report- Steve Falkenberg and Terry Logging

- We have a lease agreement with Jeff Sexton to allowing him to park his semi at the Alliance building for \$25.00/mth, with electric to be added later once the amount used is established.
- The new blade fixture for the 2017 is almost ready.
- Nate and Todd will be putting the chains on the tractors soon.
- The Alliance borrowed the Holmen club \$5000.00 to use for operating expenses until they receive the storm damage payments from the state to reimburse the Alliance.
- Linda ordered new signs from the BRF State Prison.
- The Alliance voted to renew the lease agreement with the County Hwy. Dept. if they would be willing.
  - The Commissioner responded that they are looking into the use agreement and need to reevaluate it prior to renewing any agreement.
- The trail from L&L's to the Vernon County Line will be sparsely signed to allow the county easier movements while repairing that section of road.
- There is a tree uprooted on Skinny making it a little difficult to get the groomer through. It currently fits, but it's tight.
- The ATV club will be hosting an ATV ride again on January 25th.
  - All affected landowners have given them the ok.
  - There will be dual use of ATV's and snowmobiles on this date.
- Someone suggested soliciting a list from the state of sled owners in this county to encourage participation in the clubs.
- Steve and Terry elected our club to purchase a raffle ticket for \$100.00 from the AWSC during the Alliance meeting.
