 - Burn pile needs to be burned.
 - Washout needs to be repaired as well.
- Rip Rap still needed down at Kohlmeier's.
 - Waiting for the ground to dry and the crops to come off.
- Terry is securing signatures for the new State approval.
- Terry is in the process of correcting a landowner discrepancy was discovered bordering Mark Werner's.
- Trail leaders can sign their sections as the crops and weather allow.
 - They don't need to wait for a specific trail date.

- Terry is working to rectify a trail issue regarding the land owner west of Werner's property in Barre.
 - The trail has ran on Denny Biros land when it leaves Werner's on the southern border for years, without permission.
 - We were unaware of this, believing that we were on Werner's land all along.
 - Denny has been contacted, and information has been sent to him via email along with contacting Gib Wee for assistance.
 - Denny is trying to make this land ready for sale, so he's reluctant to grant us permission at this time.
 - He's considering it.
 - The trail will need to be moved onto Octagon Farms when leaving Werner's to the south if Biros denies us the use of his land, provided Octagon/Schomberg allows it (we already have trails on multiple properties belonging to Octagon).
